It is further **ORDERED** that a list of all witnesses to be subpoenaed for any Jury Term of this Court is to be submitted to the Clerk of this Court no later than ten (10) days before the first day of said Jury Term. Any exceptions to this rule can be granted by this Court upon a showing of valid reasons why this rule has not been or cannot be followed in the interest of justice.

It is further **ORDERED** that all motions in criminal cases which require the taking of testimony are to be set specially by counsel and heard no later than the Wednesday immediately preceding the beginning of each Criminal Term, unless otherwise ordered by the Court.

All attorneys are reminded that the Court has adopted an Administrative Pre-Trial Order that is applicable in civil jury cases and each attorney should become familiar with the provisions of this order to facilitate the orderly and efficient administration of trials during each Civil Jury Term.

All attorneys practicing before this Court are expected to follow these requirements with the utmost diligence in order that court personnel and the Sheriff's Department of this county might carry out the functions expected of them without undue hardship and confusion.
